COMMUNICATIONS

The Mayor sought leave of the meeting and the meeting agreed to formally acknowledge the passing of Clem Senior former Councillor and Alderman of the City of Marion. The Mayor provided the following overview of Clem Senior's life to be recorded in the minutes.

"Clem Senior was born in 1920. He signed up in 1940 and served in an antitank unit in Greece, Northern Africa and Italy with the British Eighth Army. He married Barbara to whom he was married for 69 years. They came out to Australia in the late 1950s. In 1969 Clem was Elected to the City of Marion and he was a Member of Council for almost 35 continuous years. Clem was involved in many local projects, he was involved in setting up the production line for Chrysler when they moved to Tonsley. He worked on the contruction of the South Western Suburbs Drainage Scheme. He contributed to building a church hall on Diagonal Road which became the St Margaret of Scotland Church of England Mission. In January 2008 he was presented with an Order of Australia Medal for Service to the Community through Local Government and his involvement in ex-service and youth organisations."

- Notes the representations received in response to the community consultation required under the Roads (Opening and Closing) Act 1991 and authorise the following action to be taken to resolve the objection:
 - Grant of an easement to SA Water over the portion of the laneway adjacent 14 Nottingham Crescent Glandore.
- 2. Approves to make a Road Process Order and an Agreement for Exchange in accordance with the *Roads (Opening & Closing) Act 1991* to open and to close portions of the Glandore Laneways in the following manner:

To close:

- the section of north-south lane off Nottingham Crescent Glandore and to merge the closed road with the adjacent land comprised in Certificate of Title Volume 6177 Folio 951 (formerly Volume 5434 Folio 204) and known as 14 Nottingham Crescent Glandore subject to an easement for sewerage purposes to SA Water and:
- the section of north-south lane off Maude Street and to merge the closed road with the adjacent land comprised in Certificate of Title Volume 6177 Folio 969 (formerly Volume 5272 Folio 361) and known as 19 Maude Street Glandore; and
- to open portions of the land comprised in Certificates of Title Volume 6177 Folio 944 (formerly Volume 5205 Folio 56), Volume 5363 Folio 493, Volume 5219 Folio 284, Volume 6177 Folio 969 (formerly Volume 5272 Folio 361), Volume 6177 Folio 951 (formerly Volume 5434 Folio 204) and Volume 6115 Folio 26 as public roads.
- 3. Pursuant to Section 37(b) of the Local Government Act 1999 authorises the Chief Executive Officer to enter into and sign all documentation necessary to complete the roads opening and closure processes and transfers of land to the owners of the properties at 14 Nottingham Crescent Glandore and 19 Maude Street Glandore.
