REPORT OBJECTIVE

To nominate two Independent Members for the Warriparinga Advisory Team and recommend the nominees to General Council.

EXECUTIVE SUMMARY

The role of the Independent Members to the Warriparinga Advisory Team (WAT) was advertised as an Expression of Interest on 4 August 2021 and closed on 12 August 2021.

A total of 15 candidates applied for the role and a summary is provided in **Attachment 1**. Copies of all applications have been circulated to members of the Review and Selection Committee via email.

The panel selected candidates to progress to interview. Interviews for the shortlisted candidates were held on 20 August 2021.

This report seeks the Review and Selection Committee to formally resolve recommendations to Council for appointment of two Independent Members to the WAT.

This will be followed by a report to General Council on 24 August 2021 seeking appointment of the recommended applicants.



RECOMMENDATION

That the Review and Selection Committee:
