**By-Law 4 Part 6, Limit on dog numbers:**

- (1) The limit on the number of dog kept-
  - (a) in a small dwelling is one dog;
  - (b) on premises other than a small dwelling shall be two dogs.
- (2) No person shall without permission keep any dog on any premises where the number of dogs being kept on those premises exceeds the limit.
