

## TERMS AND CONDITIONS

Thank you for hiring a City of Marion cat trap.

Please note within 12 hours all trapped cats must either be released or taken to the RSPCA Lonsdale Animal Shelter, located at Myer Road Lonsdale. While the RSPCA does not charge for accepting stray cats a donation is always welcome.

The City of Marion does not collect stray cats. Some veterinarians within the City of Marion area will accept stray cats for a fee. Please contact them prior to attending.

### When trapping cats

Check to determine if the cat you have trapped is an **identified cat**, identification includes:

- Cat is wearing a collar with an address or telephone number of the owner.
- Cat that is microchipped will have the letter "M" tattooed inside one of its ears.

It is an offence under the Dog and Cat Management Act 1995 to trap an identified cat. If an identified cat is trapped, the animal must be returned to the place where it was trapped.

Do not enter property unlawfully to trap a cat.

### Cat cage hire

City of Marion provides cat cages on loan to residents as a service to the community as we take complaints about cats seriously. To hire a cat cage there is a deposit required in the amount of \$40. If the trap is returned within 4 weeks of the hire date then the full amount of \$40 is refunded. To obtain a refund, the cage must be returned fully cleaned and undamaged.

If the cage is not returned by the end of the 4 week period, the date of which is identified on the loan agreement, then the resident will be charged for the full replacement cost of the cat cage as we will assume that you have chosen to keep the cage. The replacement cost for each cage is \$210.00.

City of Marion has introduced this fee structure to improve service to the community by:

- Encouraging the timely return of cat cages to improve their availability.
- Using any funds accrued to maintain our fleet of cages.

The City of Marion administers and enforces the provisions of the Dog & Cat Management Act 1995.
