- 9. Authorise the Chief Executive Officer to call an open tender for Department of Transport Planning and Infrastructure pre-qualified construction firms and to report the outcome of the tenders to Council for consideration.
- 10. In accordance with Section 91(7) and (9) of the Local Government Act 1999 the Council orders that the appendices to this report and any additional information

provided at the meeting having been considered in confidence under Section 90(2) and (3)(b) and (3)(k) of the Act be kept confidential and not available for public inspection for a period of 12 months from the date of this meeting and that the report (exclusive of the appendices) be released. This confidentiality order will be reviewed at the General Council Meeting in December 2013.
