All sections must be completed. Any missing sections may cause delays or Council will be unable to process the lodgement. It is recommended this form be completed online and printed prior to lodgement. Print clearly using BLOCK LETTERS and place a TICK in appropriate boxes.

This form is to be completed prior to applying for an Extension to Planning Consent or Development Approval for a Development Application.

When a development is granted Planning Consent, the applicant typically has 2 years from the operative date in which to obtain Building Consent and Development Approval. When a development receives Development Approval, the applicant has 2 years from the operative date to substantially commence the development, and 3 years (from Development Approval) to substantially or fully complete the development.

It is recommended that this application be lodged with Council a minimum of twenty (20) business days prior to the lapsing of the Consent/Approval to allow sufficient time for the request to be considered and assessed.

Fees and Charges

An \$116* application assessment charge, per application, is payable at the time of submission. Please note payment of this fee does not guarantee an approval for an extension of time. *Fees are set by the State Government and may vary.

- 'Planning Consent' means the first consent of the application that has been granted. Typically, a 'planning consent' is valid for 24 months (i.e. you have 24 months from the date of approval to receive 'Development Approval'.
- 'Substantial Commencement' means when the relevant building works for the development are required to have commenced. Typically, works must 'substantially commence' (i.e. work is well underway) within 24 months of Development Approval.
- 'Substantial Completion' means when all building works are complete, and the buildings can be occupied. Typically, 'substantial completion' must occur within 3 years of Development Approval.
