The Acting General Manager Corporate Services and Acting Manager ICT provided an overview of the report. The Corporate Information and Communication Technology review was a cross council service review with the City of Charles Sturt and the City of Port Adelaide Enfield. The Chief Executive Officers of the three Councils are aligned in their thinking and are keen to pursue collaborative opportunities, process improvements and new initiatives to benefit our communities. The key findings from the report include establishing consistent ICT governance frameworks, implementing ICT strategy development and collaborative project delivery across all 3 councils and working towards aligning ICT platforms where appropriate. The Service Review was conducted outside of the department, namely by Erika Comrie (consultant) and the business Improvement Officer (City of Marion). The ICT Manager of Charles Sturt has also worked with the City of Marion to develop its IT Application Strategy (ITAS). The ICT review has identified many opportunities to improve ICT services as highlighted through the 37 recommendations identified in the report.

The Committee noted the report and made the following comments:

- Three Councils working together intrinsically will deliver savings
- From the Key Risks Issues and Mitigations table, would challenge that the items that are reported as mitigated and this should be monitored closely.
- In the past, Marion has invested less than the other two Councils
- Sharing an ICT resource, for example Cyber Security, across 3 Councils increases the affordability of the resource.
- Ensure resources are tracked to enable visibility of individual Council input.
- When looking at new systems be careful of heavily customised systems.
